

**Discover Seminis iX event games, Enkhuizen**  
**Terms and Conditions**

- 1.** By entering into the competition “Seminis iX event game, Enkhuizen” (“the Competition”) the participant declares and undertakes to accept and fully meet all the eligibility requirements under these Terms and Conditions (“Rules”). These Rules are available free of charge at the Organizer’s headquarters, as indicated below and on our web site [<https://5okoewi.momice.events/>] (“the Website”).
- 2.** This Competition is organized by Monsanto Holland B.V, a company organized under the laws of the Netherlands, whose registered office is at Leeuwenhoekweg 52, P.O. box 1050, 2660 BB Bergschenhoek, the Netherlands (“Organizer”).
- 3.** Participants must be at least 18 years of age on the date of entry.. Individuals that do not fulfill required age as of time of entry will not be eligible to participate in the Competition. The following are not eligible to enter Competition: (i) officers, directors, and employees of Organizer, or of any of its representatives or advertising/promotion agencies; (ii) officers, directors, and employees of Organizer, or of any of its subsidiaries or affiliates; (iii) officers, directors and employees of any dealers, sales representatives or advertising/promotion agencies of Organizer or of any of its subsidiaries or affiliates; and (iv) immediate family members of any of the officers, directors or employees listed in (i), (ii), or (iii) above.
- 4.** Participants in the Competition must apply to the Website between 21/08/2019 as of 12:00:01a.m. CET and 23/09/2019 until 11:59:59 p.m. CET for the 1<sup>st</sup> game on the registration for the 2<sup>nd</sup> game on the event they must apply at the event directly between the 23/09/2019 and 26/09/2019 and fill a paper with several questions about our varieties, partners, the event, personal details. For the 1<sup>st</sup> game to be entered into prize draw, participant must fill in his personal details on the Website and come at the event. For both games: To be valid, each entry must provide all information requested. Entries received outside this time period will not be considered. The Organizer takes no responsibility and will have no obligation to compensate participants whose entries are received outside the above time. For both games, gifts will be directly given face to face excepted if the grower is not at the event anymore, it will be sent by post within 4 weeks maximum from his participation to the Competition.  
Each participant will receive this prize on a first come first serve basis and Organizer takes no responsibility and will have no obligation to compensate participants if they do not receive this prize due to lack of stock.
- 6.** The name and city of the Winners, as well as the prize attributed to such, will be made available on the Website within 4 weeks of the relevant prize draw. By her/his participation in the competition, the participant consents that his/her name and other contact details will be indicated on the Website for the purposes of organizing this competition, publishing the names of the Winners and awarding the prizes. Any recourse regarding the draw to courts of law is excluded.
- 7.** Organizer will send the above prizes to the 4 Winners by post within 4 weeks after prize draw if they are not on site during the prize draw at the event, at Enkhuizen. The costs occurred by the transmission by post will be borne by the Organizer. Organizer accepts no responsibility for any costs associated with the prize and not specifically included in the prize. If a Winner rejects his prize or is unreachable or the entry is invalid or in breach of these Rules, the Winner's prize will be forfeited and Organizer shall be entitled to select another winner. Any prizes that cannot be issued to Winners will be rewarded in which case details of repeated draw will be shared on the Website. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.

Organizer retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available, with the amendment of these Rules on the Website.

**8.** The Organizer reserves the right in its sole discretion and without having to give a reason for the disqualification, to disqualify any entry at any time if it is determined that the participant has not complied with these Rules. In case of disqualification, Organizer reserves the right to award any prizes won to other participants. Organizers decision is final in all matters and no correspondence will be entered into on the subject of this competition.

**9.** Organizer reserves the right to cancel the competition at any time, without having to give a reason if technical, administrative or legal circumstances in any way prevent or impacts organizing and running of Competition, including but not limited to force majeure. Organizer reserves the right at its sole discretion to modify the competition conditions at any time. The early termination as well as any modification brought to these Rules shall be subject to an addendum which will be made available to the public on the Website.

**10.** The Participant declares and undertakes that the Organizer will not be held responsible for entries which are lost, delayed, misdirected or corrupted if this is not the consequence of the Organizer's actions committed with intention or severe negligence (in which case, the Organizer cannot be held liable for damages exceeding the value of the Prize), and incomplete or illegible entries and/or those not made in accordance with the Rules shall be invalid. Organizer accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by participant as a result of entering the prize draw or accepting the prize. Organizer disclaims liability for any injury or damage to participants or any other person's computer relating to or resulting from participation in or downloading any materials in connection with the competition. Nothing in these Rules shall exclude the liability of Organizer for death, personal injury, fraud or fraudulent misrepresentation as a result of its severe negligence or intentional actions.

**11.** The data supply contemplated under these Rules (*i.e.*, name and surname, email address, address, ..... ) is voluntary. For the Winners, we may need to request you to provide the personal numeric code or such other data mandatory required in order for us to fulfill the fiscal obligations vesting with us by law. By participating in this competition the participant consents that the Organizer may process his personal data for the purpose of organizing the Competition, announcing publicly the winners using the Website, awarding the prizes and meeting fiscal legal obligations. The Organizer shall ensure that the personal data is processed in a secure way in accordance with the applicable, and that the data may not be made available for third parties except when required to fulfill the above purposes (e.g., to the courier/postal operator who will deliver the prizes). For achieving one or more of the purposes referred to above, the Organizer may disclose your personal data to one or more of the following categories of recipients: your legal representatives, the natural or legal persons processing data in the name of the Organizer, the Organizer group companies, central/local public authorities, the public. Moreover, for achieving one or more of the purposes referred to above, part or all of your personal information may be transferred to countries within the EU/EEA, as well as to countries outside EU/EEA, some of which not being recognized as ensuring an adequate level of protection for personal data. The Organizer takes all necessary measures to ensure that your data is adequately protected irrespectively of where it is being transferred. The participant may ask information about the processing of his personal data, or he may request the correction of his data. The participant may also object to the further processing of his data on compelling legal grounds, unless otherwise provided by law. The participants also have the right not to be subjected to automated individual decisions. If the participant requests the deletion of his data or objects to the processing, he may not participate in this competition. The data is processed until the competition is completed and all legal requirements are fulfilled.
